Entry Fee/Payment Information:

- **\$25 entry fee** for only Bodysurfing division. **\$20** for entrants **under-18** years of age. **Cut off:** 120 competitors male & female divisions combined.
- **\$25 entry fee** for only Handboard division. **\$20** for entrants **under-18** years of age. **Cut off:** 30 male competitors & 12 women competitors.
- Shirt guaranteed for any single \$25/\$20 division entry.
- Add \$5 entry fee if interested in competing in an extra division. Extra entry does not include another competitor shirt.
- **No refunds** if contest is cancelled anytime before or during the holding period.
- ****Entry deadline: May 15, 2010 (postmarked OK). Any entries received after deadline will be considered beach entrants. \$5 beach entry fee will apply.**
- **ENTER EARLY! No refunds** for \$5 beach entry fee and **no guarantee** of beach entry.
